Resume For WILLIAM TULLEY

I was affected with the model railroad disease Christmas 1947 when I received a previously owned Lionel train set. Every Christmas after that date until 1957 had something from Lionel under the tree. Christmas 1958 brought a HO train set, which started the model railroad building phase. This phase of the disease has progressed geometrically to the present. Of course there have been lapses caused by minor irritations such as high school, colleg military service, graduate school and an attempt to earn some money working above the arctic circle as a senic construction engineer or superintendent as the job required.
